

## Identity and Purity

### Proton NMR Spectrum

Identity: the signals are consistent with the proposed structure and in accord with literature where available.

Isotopic Labelling: signals at the sites of deuteration are absent, compared with the spectrum of unlabelled material, indicating clean deuteration.

Residual Solvents: no residual solvents are observed.

Impurities: no significant impurities are evident in the spectrum.

### Carbon-13 NMR Spectrum

Identity: the signals are consistent with the proposed structure and in accord with literature where available.

Isotopic Labelling: signals at the sites of deuteration have collapsed to small multiplets compared with the spectrum of unlabelled material, indicating clean deuteration.

### High-resolution Mass Spectrum (ESI+)

Found  $m/z$  219.0947.  $C_{10}H_8D_5ClNO_2$   $[M+H]^+$  requires  $m/z$  219.0943. The deviation of 2.0 ppm is within normally accepted limits for the establishment of identity by HRMS. No signal for  $d_0$  material was seen (detection limit about 0.5 %).

### HPLC

A sharp, symmetrical peak is observed (96.2 %). Note: in the absence of reference materials for preparing calibration curves, it is assumed that all peaks have the same detector response. Where possible, the conditions of analysis follow a pharmacopeial or literature method, or have been adapted from same.

### Elemental Analysis

The elemental analyses fall within generally accepted limits for establishing the molecular formula given. The results may also be taken to imply the absence of significant quantities of water or inorganic salts (which have not been elsewhere tested for because of sample size limitations).



The re-test date is assigned from experience gained with the material in the laboratory and/or on storage. It is not possible to perform formal storage studies because of the small amount of material available.




Carbon-13 NMR Spectrum of Baclofen (top) and Baclofen-d<sub>5</sub> (bottom) in D<sub>2</sub>O


