## **Identity and Purity**

### **Proton NMR Spectrum**

Identity: the signals are consistent with the proposed structure and in accord with literature where available. Isotopic Labelling: the spectrum is of little value in determining isotopic purity. All proton signals are split by <sup>13</sup>C-<sup>1</sup>H coupling as expected.

Residual Solvents: a small amount of ethyl acetate (0.9 % w/w) is observed.

Impurities: traces of unidentified impurities are seen in the baseline.

## **Carbon-13 NMR Spectrum**

Identity: the signals are consistent with the proposed structure and in accord with literature where available. Isotopic Labelling: the spectrum is of little use in determining isotopic purity although all signals are massively enhanced and contain <sup>13</sup>C-<sup>13</sup>C coupling as expected.

Impurities: traces of unidentified impurities are seen in the baseline.

### **High-resolution Mass Spectrum (ESI+)**

Found *m/z* 220.0534. <sup>13</sup>C<sub>6</sub>H<sub>9</sub>NNaO<sub>6</sub> [M+Na]<sup>+</sup> requires *m/z* 220.0529. The deviation of 2.3 ppm is within normally accepted limits for the establishment of identity by HRMS. No signal for M-6 material was seen (detection limit about 0.5 %).

#### **HPLC**

A sharp, symmetrical peak is observed (98.7 %). Note: in the absence of reference materials for preparing calibration curves, it is assumed that all peaks have the same detector response. Where possible, the conditions of analysis follow a pharmacopeial or literature method, or have been adapted from same.

#### **Elemental Analysis**




The elemental analyses fall within generally accepted limits for establishing the molecular formula given. The results may also be taken to imply the absence of significant quantities of water or inorganic salts (which have not been elsewhere tested for because of sample size limitations).

The available quantity of custom-synthesised material is always small, and this limits the extent and type of analytical data which can be obtained. This Certificate is presented in descriptive format for use by analytical chemists who are trained in the use of custom-synthesised materials. Custom materials often contain higher levels of residual solvents and/or water, and we urge you to use the corrected purity where needed rather than the raw HPLC purity. This compound is intended for use as an analytical reference material and it is not for human administration. Structures are shown with relative stereochemistry unless otherwise specified.


The re-test date is assigned from experience gained with the material in the laboratory and/or on storage. It is not possible to perform formal storage studies because of the small amount of material available.






